**1. OPENING**

- A. Call meeting to order –President Bryan Traylor called the meeting to order at 8:04 a.m.  
Board members present: Bryan Traylor, Susana Suarez and Jason Plunkett  
Members absent: None

**2. MEETING ITEMS**

- A. Approval of minutes from the January 22, 2019 meeting: Ms. Suarez motioned to approve the January 22, 2019 minutes. Vice President Plunkett seconded, all were in favor and motion was passed.

B. Police and Fire Department Reports: None


C. Old Business:

- a. Parking at 95 S. 1<sup>st</sup> Street: Chief VanGorder gave a brief re-cap of this concern previously presented by business owner Allan Reid regarding parking concerns in front of his law firm at 95 S. 1<sup>st</sup> Street. The street is marked as a loading zone from 6am-10am, which causes a hardship for himself and his employees, one of which needs handicap parking. Staff recommended no change to North 1st Street loading zone and to amend the current loading zone times on South 1<sup>st</sup> Street from 6am-10am to 6am to 6pm. Discussion was held and options were reviewed. President Traylor motioned to amend the ordinance loading zone times on South 1<sup>st</sup> Street from 6am-10am to 6am-4pm and forward recommendation to the Town Council. Vice President Plunkett seconded, all were in favor and motion was passed. Vice President Plunkett motioned to remove the loading zone at North 1<sup>st</sup> Street from Benders Alley to Oak Street. There were no seconds, motion was not passed.
- b. Hunting Concern on Bloor Lane: Chief VanGorder reviewed the concern previously presented by resident Tom Weintraut regarding safety concerns with neighbors hunting/trespassing on his property and requested an ordinance be created to prevent this. Discussion was held and a draft ordinance was reviewed. Mr. Weintraut requested the ordinance read that hunters are required to have written permission to hunt on others property. President Traylor noted that DNR does have a form on their website that hunters are required to have if hunting on property that they do not own. Mr. Weintraut noted that he still has concerns since the ordinance allows hunters to hunt in Town on their own property. He suggested placing some sort of restriction regarding hunting on property that is near school property to protect students. President Traylor motioned to recommend approval to the Town Council on the draft ordinance regulating the discharge of weapons. Ms. Suarez seconded, all were in favor and motion was passed.
